Publication Agreement and Copyright License

This is a publication agreement and copyright license ("Agreement") regarding a written manuscript currently entitled,

The parties to this Agreement are:

(individually, or if more than one author, collectively, "Author"), and the publishing editors of "Littera et Lingua", ("Publisher").

1. The Author has created and owns the copyright to the Article.
2. The Author represents and warrants that s/he has the full power and authority to enter into this Agreement and to grant the rights granted in this Agreement. The Author represents and warrants that the Article furnished to the Publisher has not been published previously electronically. For purposes of this paragraph, making a copy of

the Article accessible over the Internet, including, but not limited to, posting the Article to a database accessible over the Internet, does not constitute prior publication so long as such copy indicates that the Article is not in final form, such as by designating such copy to be a “draft,” a “working paper,” or “work-in-progress”.

3. If the publication exist in a hard-copy form a written permission from the previous publisher must be submitted.
4. The Author and the Publisher agree that the Author may grant a Creative Commons copyright license in the Article to the general public, in particular a Attribution-Noncommercial 3.0 License, which is incorporated herein by reference and is further specified at <http://creativecommons.org/licenses/by-nc/3.0/legalcode> (human readable summary at <http://creativecommons.org/licenses/by-nc/3.0>).
5. The Author grants to the Publisher a royalty-free, irrevocable, perpetual, worldwide nonexclusive license to publish, reproduce, display, distribute, and use the Article in any form, either separately or as part of a collective work, including but not limited to a nonexclusive license to publish the Article in the Journal, its electronic archive, its paper archive, or any collection of the Journal’s works in any form whatsoever, copy and distribute individual reprints of the Article, and authorize reproduction and distribution of the Article or an abstract thereof by means of computerized retrieval systems.
6. The Author retains ownership of all rights under copyright in the Article, and all rights not expressly granted in this Agreement.
7. The Author agrees that s/he shall not publish the Article in any other journal or edited collection, whether electronic or otherwise, in substantially the same form as the Article, without acknowledging prior publication in the Journal.
8. This Agreement shall become effective and binding at the date of formal acceptance of the Article for publication by the Journal.

Submission Preparation Checklist

As part of the submission process, authors are required to check off their submission's compliance with all of the following items, and submissions may be returned to authors that

do not adhere to these guidelines.

1. The Author has read the Author Guidelines on this site.

3. The Article has not been published previously in electronic form and is not under submission elsewhere. If the Article has been published elsewhere in hard-copy form a written permission from the previous publishers should accompany the publication.
4. The Author agrees to the Author Agreement of the journal. The acknowledgment email you will receive from Littera et Lingua upon submission of your manuscript includes the Author Agreement. Please fill in the blanks, write your name and the date in the signature line, and return it via email to the editors.
5. We do not require that submitted papers be anonymous, since this is frequently an unattainable goal. However, the author of a paper has the right to remain anonymous to the reviewers throughout the review process. In that case, the author should take care to anonymize the paper, and should include in a clearly visible position on the front page the text "Submitted to Littera et Lingua for anonymous review." The reviewers are then considered under obligation not to attempt to discern the identity of the author.
